Offers apply to customers in Washington and Idaho and apply to new construction, existing homes and businesses with residential appliances. Rebates for ENERGY STAR freezers and refrigerators are available to Avista residential electric customers. Rebates for dishwashers and clothes washers are only available to Avista electric or natural gas water heating customers. **For commercial size equipment rebates call Avista before purchase. This offer cannot be combined with any other Avista Rebates.**

- Rebates listed on the front of this form are applicable to existing single and multi-family residences, including manufactured and modular homes.
- Rebates are not available for seasonal or recreational homes; only to primary living residence.
- Homeowners are responsible for complying with all applicable codes and regulations.
- Rebates are paid directly to the homeowner, multi-family property owner or business owner.
- Rebates must be submitted within 90 days of purchase or installation of the qualifying appliance(s).
- Avista reserves the right to inspect energy efficiency appliances and will coordinate inspection as applicable.
- Allow 6 to 8 weeks for processing and payment of Rebate.
